1. That the Settlor has given a sum of Rs. 5,100/- (Rupees Five Thousand One Hundred Only) to the Trust named **BHAI KANAHAIYA MANAV SEWA TRUST, SIRSA** and the receipt of the said Rs. 5,100/- (Rupees Five Thousand One Hundred Only) which the trustees hereto acknowledge, to hold the same upon trust and use the same for the purpose of the trust, subject to the power and provisions contained in this deed of trust.
2. That the trust is irrevocable and the properties of the trust shall in no event revert to the settler.
3. That the trust shall be known as **BHAI KANAHAIYA MANAV SEWA TRUST, SIRSA.**
4. That the head office of the trust shall be located at Mal Godam Road, Sirsa.
5. That the trustees shall hold property vested in them by virtue of this trust deed and any other property that may be acquired by them hereinafter on trust for the application of the corpus as well as income thereof for the advancement, furtherance and fulfillment of the following objectives: -
 - i. To look over the administration and working of the trust.
 - ii. To encourage the charitable activities and to provide free emergency ambulance for any injured person within the limits of 25 kilometers from

the Distt. Sirsa and to provide every type of help to injured persons during night at free of cost.

- iii. To provide free facility of education for poor and needy children.
- iv. To provide every type of help to the needy handicapped children/persons.
- v. To organize blood donation camp for the benefit of public at large without distinction of caste, creed and colour.
- vi. To encourage awareness among the people against the social evils.
- vii. To construct building for achieving the aims and objects of the trust and further to look over the repair, renovation of the building
- viii. To establish and maintain libraries, reference library, mobile library, reading and writing rooms in India and to furnish the same respectively with books, reviews, magazines, newspapers and other publications including instrumental and vocal music.
- ix. To make arrangements on charitable grounds for adult literary especially for illiterate adults, schedule caste/tribes, handicaps and other under privileged section of the society.

- x. To revive and propagate the Indian Culture in general and to organize deputation and cultural missions for preaching the objects of the Trust in India.
- xi. To provide for holding seminars, entertainments, meaningful lectures and to undertake the publication of works calculated directly or indirectly for the advancement of the objects of the Trust and to promote, give or support moral, social and religious orders of the Trust.
- xii. To take, receive money, acquire moveable and immovable property or other valuable security by subscription or donation without giving the donor a right to the membership of the Trust and spend through any other lawful manner for the time being in force the same in the best interest of the trust.
- xiii. To erect, construct, purchase, take on lease or hire or otherwise acquire and maintain land, buildings of required kind and necessity for the Trust in order to carry on its aims and objectives.
- xiv. To obtain recognition and financial assistance from the Government and other Institutions for implementation of the objects of the Trust.

- xv. To apply the income and properties of the Trust so derived solely towards the promotion of its objects as set for the in the memorandum.
- xvi. To do all other works for the advancement of the above purposes and to do all other charitable activities, which are duly covered under the Income Tax Act.
6. That the trustees may receive donations from the Government, Local Bodies, State Organs, Public or Private Institutions and Private Persons for the purpose of advancement of the above objects.
7. That the trustees have powers to invest the funds of the trust in such securities, Institutions or Bank as may be approved from time to time under the provisions of the Income Tax or other Acts.
8. That the Trustees shall be entitled to raise loan from Banks, Financial Institutions and any other Private Party on such rate of interest and other terms as may be applicable and agreed between both the parties. They shall also be entitled to raise such loan by way of mortgage, pledge or otherwise alienate the property of the trust. Shri Gurvinder Singh or any other person duly authorized by the Trustees shall be entitled to execute pledge deed/mortgage deed or any other documents which may be required to be executed by the lender, President or any other person as may be authorized by the board of Trustees shall be entitled to operate the said loan account/accounts in the best interest of the Trust. It is further cleared that the raising of loan by way of security against the property of the Trust shall be only for the purpose of developing the objects of the Trust incorporating hereunder.
9. That the President and any other Trustees so empowered shall have the right to sue or to be sued on behalf of trust any legal action or cases in accordance with resolution or wishes or the Trustees. He shall be entitled to apply to Taxation Authorities for any refund due to the Trust and to receive the Authorities for any refund due to the Trust and to receive the same. He shall also be entitled to make any application to any Court, Office, Taxation Authorized in respect of matters relating to this Trust.

10. That the Trustees shall have absolute discretion in determining the nature & character and structure of buildings necessary for carrying out the objects of the Trust.
11. That the Trustees shall have full powers to enter into contracts for carrying out the objects of the Trust and to employ and terminate professional persons, clerk, servants etc. on such salary and terms deemed fit and proper by them and to do all other acts and things incidental or necessary in that connection.
12. That the first Executive Committee shall consist of the following persons:-
 - a. President Sh. Gurvinder Singh Kuka
 - b. Vice President Sh. Ranjiv Kumar Garg
 - c. Secretary Sh. Rishi Pal Jindal
 - d. Cashier Sh. Harbans Lal Jindal
 - e. Auditor Sh. Bhoop Singh Soni, Advocate
 - f. Member Sh. Hardev Singh
 - g. Member Sh. Balraj Singh Bajwa

The first tenure of Executive Committee of the Trust is permanent unless otherwise determined by the Trustees.

13. That the trust may open bank account in any nationalized or private bank. President along with Secretary or Cashier are entitled to operate upon the bank account.
14. That the Trustees shall not be liable for any loss not attributable to their own dishonesty or to the willful negligence of any act known to them to be breach of the Trust and in particulars any one trustee shall not be entitled to take proceedings against another trustee.
15. **Revocation of trustee from the executive committee:**
 - a. On death of trustees, or if the trustee gives resignation letter and the same is accepted by the executive committee or if the trustee is found guilty or misconduct.
 - b. If the trustee works against the rules and regulations, objects and welfare of the trust, then the executive committee shall have the power to revoke the membership of the trustee with the majority of the 70 percent of the members of the trust.

16. Any change in the rules and regulations of the trust can be made with the majority of members, which shall not be less than 70 percent of the members of the trust.
17. **Quorum:** Quorum of the meeting of the executive committee shall be completed with the presence of 50 percent of the members of the trust.
18. That the meeting of the trustees shall be held at least once in a year. The trustees shall also hold such other meetings from time to time as may be necessary for furtherance of its objectives.
19. That the Trustees shall be entitled to frame rules for the Management and Administration of the Trust, for convening meeting of the Trust and for conduct the business therein. They may delegate any of the powers and duties to any one or more of the Trustees or Sub/committee of the Trustees by a Resolution passed in this respect for the purpose of doing such specific work or works or for attending day to day business of the Trust and its Institutions.
20. That all business in the meeting of trustees shall be decided by majority and such decision of the majority shall be subject to approval of the president of the Trust. If the President so desire he can over rule any decision of the Trustees and decision taken by him shall be final and binding.
21. A minute book shall be provided and kept by the Trustees. This shall contain the proceedings of the meetings of the trustees and shall be signed by the Chairman of the meeting at conclusion or at the subsequent meeting when they are fully confirmed.
22. That the trustees shall maintain true and complete account of all money received or spent by the Trustees or of matters in respect of such receipts and expenditure taken place and of properties, credits and liabilities of the Trust. The account shall be made up at the end of every year ending 31st March (Financial Year) or upon any other period the Trustees may determine from time to time. Such accounts and Balance Sheet shall be examined and passed by the Trustees at their first meeting in the year following or at such other meeting as may be called for that purpose. Such accounts shall got audited by person duly qualified to conduct audit under the provisions of the Companies Act.

23. That such other properties or amount as may be donated by the founders of the Trust or by any other persons or Institutions shall also form part of the Trust property and shall be held by the Trustees in Trust for furtherance of the objects of the Trust.
24. That the board of Trustees shall have the power to appoint a Managing Committee and its members. Such Committee may be formed for Managing different activities. Such Managing Committee may have its own office bearers. The board of Trustees shall appoint members of such Managing Committee, which may include the members of Trust and other outsiders also. The Board of Trustees may remove any member of the Managing Committee from time to time by the Majority decision.
25. That non-filling of any vacancy that may be caused will not invalidate the proceedings of the Trust or any thing or act done by the Trustees. Similarly the appointment of Managing Committee shall not divest the Board of Trust for their powers to act and administer the Trust.
26. That the maximum number of Trustees shall be limited to Twenty One and Power of appointing new trustees shall be vested in the Board of Existing Trustees. New Trustees can be appointed by a Resolution passed on majority basis in a meeting held of Existing Trustees.
27. That the Trustees shall have power to invite non-trustees to the meeting of trust for advice, information or direction as deemed fit and proper by them from time to time.
28. That no expenditure of the Trust shall be invalid for want of prior sanction and the said sanction may be granted even after the expenditure is made by the Trustees.
29. That the provisions of the Indian Trust Act shall apply to this Trust to the extent these are not inconsistent with the above provisions.
30. That in the event of dissolution of trust, the properties of trust will merge in any other trust having charitable objects & in no event, the properties of the trust will go to its trustees.
31. That the Boards of Trustees shall be duly competent to make addition, deletion, alteration and any other change in the Trust Deed for smooth and proper running of the Trust.


